

1 Information for the Patient

1.1 Secure information processing

ALETTA safeguards the personal data of the Patient from tampering and unauthorized access. All communication between the app and ALETTA server is secured via HTTPS. Authentication is done on a personal and medicine level. Personal authentication is performed by the Pharmacy which verifies the identity of the Patient manually before an account is created for the Patient to use the ALETTA app.

Furthermore, the ALETTA app includes proprietary medicine authentication technology as a counterfeit medicine-detection tool. Before the Patient is allowed to use the app, the Patient needs to scan the medicine. ALETTA will then verify the authenticity of the MYCB1 medicine. After successful verification, the Patient can proceed to use the app.

MYCB1 complies with the international standard for information security ISO 27001:2017 and the standard for information security for the Dutch healthcare sector NEN 7510-1:2017. Further information regarding the scope of this certification and applicability of the management system requirements can be obtained by contacting the certified organization Brand Compliance at brandcompliance.com.

1.2 How to Use ALETTA correctly

The ALETTA app requires the Patient to fill in the ED-5Q questionnaire on a frequent basis according to the doctor's instructions, during the usage of the prescribed MYCB1 medicine. The questionnaire consists of simple questions in 5 dimensions to address the Patient's Quality Of Life. It's important that the Patient itself answers the questions to ensure authentic answers. This guarantees the treating doctor that the questionnaire has been filled in correctly.

1.2.1 Physical Impaired Patients

In case the Patient is unable to fill in the ED-5Q questionnaire on the app him/herself due to physical impairment (bad eyesight, unable to handle the mobile app on the phone physically or other), the Patient is advised to ask somebody to assist him/her by reading the questions aloud and filling in the answers for the Patient directly. This needs to be done every time the Patient needs to report his/her health status.



2 Mobile App

You can access ALETTA via the mobile ALETTA app. The app is downloadable from iOS Apple App Store and Android Play Store.

2.1 First time usage

After downloading and installing the app, click *CREATE A NEW ACCOUNT*:




ALETTA App: login

You need to activate the app first by scanning a QR code.

2.1.1 Using ALETTA with a prescribed medicine

If you are using the ALETTA app in combination with a prescribed medication from your doctor, you will receive the medication from your pharmacy with a QR code attached to it. Scan this code with the ALETTA app when you create an account.

This scan verifies the authenticity of the medicine.

2.1.2 Using ALETTA with no medicine

If you are using the ALETTA app without medication, you will receive a QR code from the ALETTA Support Team via email. Scan this code with the ALETTA app when you create an account.

The scan will activate the ALETTA app.

2.2 Successful verification

Upon successful verification, the app will show a message that the medicine has been verified.





Fig. 24 ALETTA App: MYCB1 Medicine verification






ALETTA App: Select your language

2.3 Medicine information

The ALETTA App menu consists of three main items: **Medicine**, **Diary** and **More**. *Medicine* will show detailed product information about the medicine including its serial number, confirmation that it is a verified product, risks and side-effects.




ALETTA App: MYCB1 Medication Information

2.3.1 Report Side Effect

If you experience side-effects with the usage of your medication, you can report this via the ALETTA App. Click **MEDICINE** - Click **REPORT SIDE EFFECT**. You can now select the side-effects that are applicable. After completing, click **SUBMIT**. This report will be emailed to ALETTA Support Team and your treating doctor.

2.4 Diary


To create a report, go to **Menu - Diary**. Press **Plus sign** to create a new report.

2.4.1 Dose

Enter the dose intake of the medicine by moving the vertical sliding bar. If you are using the ALETTA App without medication, enter "0" for Dose.




ALETTA App: Enter the medicine dose

Press *Send*. The report will be sent to your treating doctor. You can also choose to make a report on your state of health by pressing *Do Questionnaire*








