ALETTA 1.0 FREE SOFTWARE LICENSE

This Software License Agreement (the "Agreement") is effective as of the signed date (the "Effective Date").

By signing this form you (the "Licensee") agree to this FREE SOFTWARE LICENSE between you and **MYCB1 Group B.V.** (the "Licensor"), a company organized and existing under the laws of The Netherlands, with its head office located at Watteaustraat 5-2, 1077 ZH Amsterdam, The Netherlands.

1. GRANT OF LICENSE

- 1.1. Licensor hereby grants to Licensee a personal, non-exclusive and non-transferable right to use a free version of the software set forth in Schedule A (hereinafter "Licensed Software"), which is accessible via a web browser using the personal account of the Licensee, set forth in Schedule A for a limited period of time until the date specified in Schedule A. The license hereunder is granted free of charge.
- 1.2. Licensee shall use the Licensed Software only for its own business purposes and not for providing commercial consulting, timesharing or programming services or commercial products to Other Persons. "Other Persons" are individuals, firms, or corporations outside the Licensee, its divisions and its majority-owned subsidiaries.
- 1.3. The license hereunder is personal and Licensee shall not sell, assign, lease, sub-license or otherwise publish the Licensed Software or any copy thereof to any Other Person. Licensee shall not disclose the Licensed Software to any consultant retained by Licensee except with the prior written consent of Licensor.

2. INTELLECTUAL PROPERTY AND CONFIDENTIALITY

- 2.1. All intellectual property rights such as but not limited to patent rights, copyrights and related rights (including rights in source code and object code), trademark rights, trade name rights, rights in designs, rights in computer software, database rights, rights in confidential information (including know-how and trade secrets) and any other intellectual property rights, in each case whether registered or unregistered and including all applications (or rights to apply) for, and renewals or extensions of, such rights and all similar or equivalent rights or forms of protection which may now or in the future subsist in any part of the world, in or in connection with the Licensed Software are and shall remain the exclusive property of Licensor. Licensee acknowledges and respects the rights of Licensor in the Licensed Software.
- 2.2. Licensee shall not copy or otherwise reproduce any part of the Licensed Software without the prior written consent of Licensor. Licensee agrees that it shall not allow any Other Person to copy any portion of the Licensed Software for any purpose whatsoever. Licensee shall not remove any copyright or other proprietary notices from the Licensed Software.

- 2.3. Licensee acknowledges that the Licensed Software contains Licensor's know-how, certain object code computer programs and associated documentation, manuals and other printed or visually-perceptible materials describing the use or design of the Licensed Software. Licensor's know-how includes the valuable, confidential and proprietary information developed by Licensor from time to time relating to the contents, working, installation and implementation of the Licensed Software. The Licensed Software incorporates automatic shutdown features which make it inoperable after the termination date.
- 2.4. Licensee shall treat all Licensed Software to which it has access with at least the same degree of confidentiality as Licensee keeps its own confidential information. Licensee shall safeguard any and all copies of the Licensed Software against unauthorized disclosure, shall not tamper with, bypass or alter its security features or attempt to do so, and shall take all reasonable steps to ensure that the provisions of this Agreement are not violated by any person under Licensee's control or in Licensee's service. Licensee also agrees that it shall neither cause nor permit any person under its control or in its service in any way to disassemble or attempt to disassemble the Licensed Software object code.
- 2.5. The confidentiality obligations shall not apply to information that has been:
 - 2.5.1. developed by Licensee independently of Licensor, without violation of this clause, as evidenced by Licensee; or
 - 2.5.2. rightly obtained by Licensee without restriction, from a third party who has the right to transfer or disclose it, and without violation of this clause as evidenced by Licensee; or
 - 2.5.3. publicly available other than through a violation of this clause, as evidenced by Licensee.
- 2.6. Licensee acknowledges that the Licensed Software is a unique, confidential and valuable asset of Licensor, and that Licensor shall have the right to seek all equitable and legal redress which may be available to it for the breach or threatened breach of this Agreement. Licensor shall have the absolute right to limit, terminate, revoke or cancel Licensee's right to use the Licensed Software upon the breach of any term under this Agreement.

3. WARRANTIES AND UNDERTAKINGS

- 3.1. Licensor represents and warrants to Licensee that Licensor is authorized to grant the license hereunder and, to the best of Licensor's knowledge, the Licensed Software does not infringe upon any copyright or other proprietary right of others.
- 3.2. Licensee shall not use the Licensed Software in any way that causes, or may cause, impairment of the availability or accessibility of the Licensed Software or any damage to the Licensed Software or MYCB1.
- 3.3 Licensee furthermore warrants and guarantees:
 - i) not to use the Licensed Software for other purposes than the intended use;
 - ii) not to use the Licensed Software (or part thereof) for any illegal, fraudulent or unauthorized purpose;
 - iii) not to sublicense, lease, (re)sell, rent, transfer, distribute, copy, modify, decompile or reverse engineer the Licensed Software (or part thereof);
 - iv) not to conduct or request that any other person or party conduct any load testing or penetration testing in relation to the Licensed Software;
 - v) not to infringe upon or violate MYCB1's intellectual property in or in connection with the Licensed Software;
 - vi) not to upload or transmit viruses or any other type of malicious or destructive code via the Licensed Software;

- vii) not to interfere with or circumvent the security features of the Licensed Software (or part thereof).
- 3.4 Licensee acknowledges and accepts that MYCB1 retains the right to remove any information or content that is deemed to MYCB1's sole discretion in violation of this Agreement, and in particular the warranties and prohibited uses as stipulated above. MYCB1 also has the right to immediately suspend or terminate Licensee's access to and use of the Licensed Software in the event of such violation.
- 3.5 MYCB1 reserves the right to modify (including but not limited to adding or removing features), discontinue or terminate the Licensed Software or any part thereof, for any reason without notice and at any time. MYCB1 cannot be held liable for damages or loss of Licensee or any third party as a consequence of any such modification, discontinuance or termination.

4. DISCLAIMER AND LIMITATION OF LIABILITY

The use of the Licensed Software under this Agreement is provided "AS IS". EXCEPT FOR THE FOREGOOING EXPRESS WARRANTIES, LICENSOR NEITHER MAKES NOR GRANTS ANY OTHER WARRANTIES, EXPRESS OR IMPLIED. LICENSOR EXCLUDES ALL IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR PARTICULAR PURPOSE. LICENSEE AGREES THAT LICENSOR WILL NOT BE LIABLE FOR ANY SPECIAL, INDIRECT OR CONSEQUENTIAL DAMAGES, INCLUDING, BUT NOT LIMITED TO, LOSS OR USE OR THE LOSS OF DATA OR INFORMATION OF ANY KIND, HOWEVER CAUSED.

5. TERMINATION

- 5.1. This Agreement shall automatically terminate on the earlier of (a) the termination date as specified in Schedule A or (b) immediately, if any provision, covenant or obligation under this Agreement has been breached, without prejudice to the other statutory rights of Licensor, for example the right to claim damages in this respect.
- 5.2. This Agreement shall also terminate with immediate effect if (a) Licensee has been declared bankrupt or has been granted with suspension of payment, or (b) an assignment is made by Licensee for the benefit of creditors, or (c) Licensee ceases conducting business in the ordinary course, or (d) Licensor ceases the use or development of the Licensed Software.
- 5.3. Upon termination, regardless of the reason thereof, Licensor is entitled to immediately suspend and terminate Licensee's access to the Licensed Software without incurring any liability whatsoever towards Licensee.
- 5.4. Upon termination, regardless of the reason thereof, Licensee shall immediately discontinue any and all use of the Licensed Software and return to Licensor any and all confidential and proprietary information without retaining any copies thereof, unless required under applicable statutory law.

6. GENERAL TERMS

6.1. 6.2. If any provision of this Agreement shall be held to be invalid or unenforceable, this shall not affect the enforceability of the other provisions of the Agreement. In such event, the invalid or unenforceable provision shall be replaced by Licensor by a provision that is valid and enforceable thereby taking into account the intent and purpose of the original provision.

7. APPLICABLE LAW AND COMPETENCE

- 7.1. This Agreement shall be governed and interpreted exclusively in accordance with the laws of The Netherlands.
- 7.2. Any disputes arising from or in connection the Agreement that cannot be resolved amicably between Licensor and Licensee shall be exclusively governed by the court of Amsterdam.

SCHEDULE A LICENSED SOFTWARE

ALETTA is a cloud base IT data management platform developed by MYCB1 Group B.V, that is built in with the validated questionnaire ED-5Q, a standardized instrument for measuring generic health status that is designed for self-completion and as such captures information directly from the respondent, thereby generating data that conforms with the general requirement of all Patient Reported Outcome (PRO) measures.
